What are the requirements to become an eligible candidate?

- Be 18 years of age or older.
- Be one of the following: resident, residential owner, business representative, community organization representative or an at large candidate who lives or works within the boundaries and qualifying areas for DCPC. (See map)
- Candidates must meet eligibility requirements for both neighborhood and category.
- **Have proof of eligibility.**

Important Due Dates

Candidate registration forms are due by **5:00 pm on Monday, February 21**, to enable printing candidate names on election ballots. If your registration form is received after the deadline, you will be considered a write-in candidate.

The Candidates' Forum will be held at **6:00 pm on Monday, March 6** (Lyceum at Horton Plaza). Though not required, you will have the opportunity to give a brief campaign speech.

To the City Council of the City of San Diego:

 - B. Deed of Trust or Property, property tax bill, sales contract, mortgage payment contract or book, or current County Tax Assessor property owner listing.

- A. California driver's license or picture identification card **AND**
 - B. Business license (not a professional license), certificate of incorporation, articles of incorporation, deed of trust, property tax bill, current County Tax Assessor listing or property owner listing. If you are not the primary business owner, you must also provide a letter from a Company Officer indicating the company's sponsorship of your candidacy.

- Representative of a community organization** (*A Community Organization means any nonprofit association of persons and/or entities that has its headquarters, a satellite office or a substantial number of constituents/service-recipients within the Downtown Community Plan Area boundaries.*)

- A. California driver's license or picture identification card **AND**
 - B. Proof of organization's existence and operation within Downtown Community Plan Area boundaries, such as articles of incorporation, by-laws, nonprofit status, or business license **AND**
 - C. Resolution or minutes of the organization legislative or executive body, designating you as its representative to DCPC.

- At Large Candidate** who meets one of the above categories

At Large candidates must qualify under one of the above four categories and provide the same documentation required for that category.
